



News: (Q1 Un-audited): The Company has reported its profit after tax of Tk. 24.84 million and basic EPS of Tk. 0.75 for the 3 (three) months period ended on 30 September 2017 (July-September, 2017) as against profit after tax of Tk. 19.24 million and basic EPS of Tk. 0.58 for the same period of the previous year. It is to be noted that basic EPS has been calculated based on weighted average Pre-IPO paid-up number of shares i.e. 33,000,000 shares for both the periods. However, considering Post-IPO 48,000,000 number of shares the Company's basic EPS for the 3 (three) months period ended on 30 September, 2017 would be Tk. 0.52 and NAV per share would be Tk. 16.10 as on 30 September 2017.
