



News: Referring to their earlier news disseminated today the Company has provided the following correction news: "The Board of Directors has decided to restrain the involvement of the Company from all other consortiums which were formed earlier to perform power business with other partners of the consortiums. and form a new Consortium in the name of Paramount Acron Energy Consortium consisted by 1. Paramount Textile Ltd., 2.
