Today first 20 minutes of the trading hour market experienced a massive fall and sliding down to 5771.48 points though later it recovered and lost only 18.51 points to close at 5869.79 point. Total turnover stood 440.4 crore which was 20.70% higher than previous session. Pharmaceuticals and Telecommunication sector got higher market composition than last day. GP, SQURPHARMA, BXPHARMA, LANKABAFIN and BRACBANK were the top turnover leaders of Dhaka Stock exchange.


