

DAILY MARKET COMMENTARY: WEDNESDAY FEBRUARY 28, 2018 Today market shows a volatile condition almost all the day. Trading session starts with negative momentum though after 12 pm it starts to fall and continue till end of the day. Today benchmark index of DSE, DSEX index closed in green today though turnover was not satisfactory. DSEX index gained 6.51 points to close at 5804.94 point. Total turnover stood 389.05 crore which was 20.86% higher than previous session. Pharma, ENGINEERING, NBFI, MISCELLANEOUS, CEMENT and CERAMIC sector got higher market composition than last day. IFADAUTOS, LANKABAFIN, LAFSURCEML and SQURPHARMA were the top turnover leaders of Dhaka Stock exchange.


