

DAILY MARKET COMMENTARY: TUESDAY APRIL 03, 2018

After three consecutive bullish candles, market closed in red today. Market starts with positive momentum but after 5 minutes DSEX index starts to lose its value. From 10.45 DSEX index again starts to rise though from 12.30 PM DSEX index again starts to fall and continued till end of the day. Finally DSEX index settled in 5790.29 points by losing 37.23 point. Total turnover stood 552.21 crore which was 7.41% lower than previous session. Engineering and Cement sector got higher market composition than last day. BEXIMCO, IFADAUTOS, BXPHARMA and CITYBANK were the top turnover leaders of Dhaka Stock exchange.


