Market closed in green today. Market starts with positive momentum but 10.50 AM DSEX index starts to lose its value. From 11.30 DSEX index again starts to rise and continued till end of the day. Finally DSEX index settled in 5841.19 points by gaining 48.14 point. Total turnover stood 572.04 crore which was 4.64% higher than previous session. Pharmaceuticals, Miscellaneous and telecommunication sector got higher market composition than last day. GP, BEXIMCO, BRACBANK, SQURPHARMA and UNIQUEHRL were the top turnover leaders of Dhaka Stock exchange.


