

# DAILY MARKET COMMENTARY: MONDAY APRIL 16, 2018

Market starts with positive momentum but after 10 minutes of trading session general index of DSE, DSEX index starts to fall and reached its lowest value at 1.15 pm. After that DSEX index again starts to rise and continued till end. Finally DSEX index settled in 5784.67 points by gaining 11.07 point. Total turnover stood 515.6 crore which was 25.07% higher than previous session. Bank, Engineering and Food sector got higher market composition than last. BEXIMCO, BRACBANK, ADVENT, MERECANBANK and LHBL were the top turnover leaders of Dhaka Stock exchange.


