Market closed in green today. Market starts with negative momentum but after half an hour of trading session general index of DSE, DSEX index starts to rise and continued till end of the day. Finally DSEX index settled in 5822.96 points by gaining 45.02 point. Total turnover stood 561.4 crore which was 10.56% higher than previous session. Bank and Telecommunication sector got higher market composition than last day. ISLAMIBANK, BEXIMCO, GP, ALARABANK and BRACBANK were the top turnover leaders of Dhaka Stock exchange.


